3. Preference will be given to presentations that are:
 - a. Presented or co-presented by Aboriginal and Torres Strait Islander peoples and community members.
 - b. Showcase strategic partnerships and Aboriginal leadership
 - b. Evidence or outcome based (what is working).
 - c. Identify key learnings.
